# **Guidelines Career Counselling Programmes**

Organized by Regional Councils/Branches/CPE Study Circles/ CPE Study Chapters/CPE Study Groups of ICAI

**Objective:** Popularise CA Course.

**Programme Organizing Units (POUs):** Regional Councils /Branches/ CPE Study Circles/CPE Study Chapters/CPE Study Groups of ICAI.

#### A. Grant

#### Notes:

- Total expenditure shall not exceed the eligible Grant per programme. Expenditure includes all items like cost of Banner, Memento to School/College Head, Photographs, Conveyance, etc.
- Lumpsum Grant of Rs. 9,000 + GST per programme will be given to the POUs irrespective of the actual expenditure incurred by the POUs.
- The POUs shall pay honorarium to the Counsellors directly. However, the honorarium shall not exceed Rs. 6500/- per programme.
- The POUs shall ensure that the Counsellors engaged will be experienced and quality of the Programme should be ensured at all levels. In case, the Committee receives any complaint or grievance from any quarter regarding the programme, the payment / non-payment of the grant for the programme shall be at the discretion of the Committee.
- More than one Counselling Session conducted in one School/ College in a single day shall be treated as one session only and the grant also shall be restricted to Rs. 9,000/- to the respective POUs.
- Career Counsellors who are directly / indirectly engaged in private coaching centers shall not undertake the aforesaid career counselling programmes. The Counsellor shall not publicize the credentials or any sort of canvasing for the private coaching centers or Centers in the aforesaid career Counselling programmes. It may be stated that a member of the Institute, whether in practice or not, shall be deemed to be guilty of professional misconduct if he contravenes any provision of the Chartered Accountants Act, 1949 or the Regulations framed thereunder or any quidelines issued by the Council/ Committee, ICAI.

#### **Mega Career Counselling Programme**

Large	1001-2500 Members	1750	50,000
Mega	2501 and above Members	2000	60,000

#### Notes:

- Maximum eligible Grant or Actual Expenditure incurred whichever is less will be considered.
   Actual expenditure shall not in any case exceed the Maximum eligible Grant.
- Reimbursement will be done on receipt of the signed Statement of Expenses by the POU along with all supporting documents.
- Press Meet/Press Release is mandatory for all the Major Mega/Mega Career Counselling Programmes.
- GST is payable extra at actuals.
